GLCKCSC Inc. Membership Process and Application

GLCKCSC Inc. membership is open to individuals nine years of age or older. The application process takes approximately three months from the time we receive the completed application until the time an applicant is accepted into membership. It is important to volunteer your time and be active within the GLCKCSC Inc. to further the club's goals, no matter the type of membership you select.

Types of Membership

These are the types of membership open to all persons nine years of age (must have a regular member parent/guardian) and older who subscribe to the purposes of the club and are in good standing with the AKC. Members 9-17 years of age will remain Associate Members' until the age of 18 after which they can apply for Full Membership status.

- Associate Membership: Enjoy privileges of the club with the <u>exceptions</u> of: the right to make motions, vote, be listed in the Breeder's Directory, publish litter listings, or hold office. This is available as either Single or Family. In order to attain Full Membership, a member must hold an Associate Membership for one (1) year.
- Once Full Membership requirements are fulfilled, an Associate Member(s) may apply for a Full Membership application.
- These requirements must also be completed yearly to retain Full Membership status:
 - 1. Attend two (2) meetings; gavel to gavel.
 - 2. Work/volunteer at one (1) GLCKCSC Inc. function.
 - 3. Give one (1) donation of services, time volunteering, or sponsorship.
- **Full Membership:** Enjoy all the privileges of the club. Available as Single or Family (husband and wife or two persons living in the same household, who each enjoy all the privileges of the club).

Privileges of Full Membership include: the right to make motions, debate, vote, be listed in the Breeder's Directory, publish litter listings, the right to post on their website that they are a member of the GLCKCSC Inc., and hold office.

- 1. Attend two (2) meetings; gavel to gavel.
- 2. Work/volunteer at one (1) GLCKCSC Inc. function.
- 3. Give one (1) donation of services, time volunteering, or sponsorship.
- 4. Associate Membership applicants need minimum of two (2) GLCKCSC Inc. members in good standing complete the sponsorship section.
- 5. Read and sign the Code of Conduct (signature of all applicants is required yearly).
- 6. Applicants must sign and date the application.
- 7. Once completed in full, forward your application to the Membership Chair for processing.

Please contact the GLCKCSC Inc. Membership Chair or Corresponding Secretary if you need help in locating GLCKCSC Inc. members in your area to act as your sponsors.

New members, upon receiving your application, the Membership Chair will review and present the application to the GLCKCSC Inc. Board for review. Once reviewed by the Board, if no objections to the pending applicant(s), a motion will be passed to present the membership application for a vote at the next membership meeting. The Membership Chair will contact you and let you know that your presence will be requested at the meeting when your application is presented. Members will have the opportunity to ask and answer questions, after which a secret vote will be completed. If approved, you will be welcomed as an official member of the GLCKCSC Inc.

Renewal members will automatically be renewed as a regular status member if all requirements for regular membership have been fulfilled and a current signed Code of Conduct is on file with the Membership Chair.
